All styles and themes of art are welcome as long they are within the guidelines of CCAA. Each artist may only submit three original artworks, ready-to-hang with wire on wall pieces or display. The piece must not exceed 14 inches x 14 inches, including the frame for framed pieces. All participants must be current CCAA members. **Not a member, join now for \$35.00 or \$30.00 if over 55.**

Entry Fees:

3 pieces of art per member for \$25.00 and any work sold can be replaced by the artist at no additional cost. It's up to each individual artist to monitor the sale for replacement.
